Section 4 - FIRST AID MEASURES

First aid measures for different exposure routes

INHALATION: Remove to fresh air. If not breathing, give artificial respiration. if breathing is difficult, give oxygen. Get immediate medical attention. Do NOT use mouth-to-mouth resuscitation. If you experience difficulty breathing, leave the area obtain fresh air. If continued difficulty is experienced, get medical assistance immediately.

Section 5 - FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA: Dry Chemical, Dry Sand, Water Fog

UNUSUAL FIRE AND EXPLOSION HAZARDS: Combustion generates toxic fumes of carbon monoxide, carbon dioxide and other gases. No unusual fire or explosion hazards noted. Section 6 - ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

FOR NON-EMERGENCY PERSONNEL: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Do not breathe vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

FOR EMERGENCY RESPONDERS: If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For non-emergency personnel".

Methods and materials for containment and cleaning up

SMALL SPILL: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. Prevent entry into sewers, watercourses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Precautions for safe handling
