Section 4 - FIRST AID MEASURES

First aid measures for different exposure routes

INHALATION: Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. Do NOT use mouth-to-mouth resuscitation. Section 5 - FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA: Alcohol Film Forming Foam, Carbon Dioxide, Dry Chemical, Dry Sand, Water Fog.

UNUSUAL FIRE AND EXPLOSION HAZARDS: Isolate from heat, electrical equipment, sparks and open flame.

Vapors can travel to a source of ignition and flash back. Vapors may form explosive mixtures with air. No unusual fire or explosion hazards noted.

Closed containers may explode when exposed to extreme heat due to buildup of steam. Keep containers tightly closed. Combustible liquid and vapor.

Section 6 - ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED: Contain spilled liquid with sand or earth. DO NOT use combustible materials such as sawdust. Eliminate all ignition sources; use explosion-proof equipment. Place material in container and dispose of according to local, provincial, state and federal regulations. Do not incinerate closed containers. Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools.

Section 7 - HANDLING AND STORAGE

PRECAUTION FOR SAFE HANDLING: Remove all sources of ignition, including flames, heat, and sparks. Take precautionary measures against static discharges. Ground and bond containers and equipment before transferring to avoid static sparks.

CONDITIONS FOR SAFE STORAGE: Store in cool, dry, well-ventilated area. Use with adequate explosion proof ventilation, isolate from sources of heat, sparks or flames. Extinguish all sources of ignition include remote pilot and lights. Maybe harmful is swallow or inhaled.
